### *Information to follow for Final Approval:*

1. Copy of Lease Agreement (if applicable)
2. Copy of Articles of Incorporation and/or Business Registration (if applicable)
3. Copy of Broker Agreement or Transportation Authorities (if applicable)
4. 2<sup>nd</sup> Piece of identification i.e. Citizenship, Birth Certificate, Passport or Social Insurance Number (SIN)
5. Proof of wage/income and Financial or Bank Statements
6. Void Cheque (for pre-authorized payments)
7. Copy of Final Dealer invoice signed by owner

### *Please note:*

1. *If all the required quote information is received initial approval turnaround is expected to be within two to four hours. Lack of proper information increases the timeframe for initial approval.*
2. *Initial approval is granted to the client based on our estimated asset coverage and provided information.*
